<u>ANNEX</u>

Annexes VII and XIII of Regulation (EU) 2019/1241 are amended as follows:

(1) in Annex VII, in Part C, point 5.1 is replaced by the following:

'5.1. From 1 February to 30 September each year, fishing with bottom set longlines (LLS) and bottom trawls (OTB) in the western area of the Cantabrian Sea, opposite to Asturias and Galicia, shall be prohibited within the geographical areas enclosed by sequentially joining with rhumb lines the following coordinates, which shall be measured according to the WGS84 system:

- (2) in Annex XIII, Part A is amended as follows:
 - (a) point 3.1 is replaced by the following:

'3.1. Fishing shall only be permitted with pots, fish traps and longlines within the following areas enclosed by sequentially joining with rhumb lines the following coordinates, which shall be measured according to the WGS84 system:

'Northern Midsea Bank':

(b) Point 3.3. shall be amended as follows:

'Between 1 November and 31 January, fishing with static nets¹ shall be prohibited in the areas enclosed by rhumb lines, seaward separation lines of the German EEZ^2 or delimitation lines of the German territorial sea³ sequentially joining the following sets of coordinates, which shall be measured according to the WGS84 system:'

(c) In point 3.3, the sections 'Natura 2000 site 'Adlergrund (DE1251301)', 'Natura 2000 site 'Westliche Rönnebank' (DE1249301)' and 'Natura 2000 site 'Pommersche Bucht mit Oderbank' (DE1652301)' are replaced as follows:
