Subject:	Council position on draft amending budget No 3 to the general budget for 2021: Entering the surplus of the financial year 2020
	<ul><li>Adoption</li></ul>

1. On 15 April 2021, the Commission submitted to the Council draft amending budget (DAB) No 3 to the general budget for 2021 concerning the budgeting of the surplus resulting from the implementation of the budget year 2020.

The implementation of the budget year 2020 shows a *surplus* of EUR 1 768.62 million resulting from:

a) a positive outturn in the revenue part of the budget (+EUR 1 647.32 million) of which:

Title 1 (Own resources): +EUR 309.67 million

Title 3 (Surpluses, balances and adjustments): +EUR 1 065.04 million

Title 7 (Interest on late payments and fines) +EUR 267.99 million

Other titles +EUR 4.62 million

- b) an under-implementation on the *expenditure side of the budget* (-EUR 121.30 million), notably of:
  - appropriations authorised in the 2020 budget (Commission and other institutions):
     EUR 221.36 million
  - cancellation of appropriations carried over from 2019 (Commission and other institutions):
     EUR 107.35 million
  - exchange rate variations

+EUR 207.41 million

The budgeting of this surplus will diminish accordingly the global contribution of the Member States to the financing of the EU budget in 2021.

- 2. The <u>Budget Committee</u> examined DAB No 3/2021 at its meeting on 21 April 2021 and was able to accept it without any changes.
- 3. At the close of its examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
  - adopt the Council's position on DAB No 3/2021 as set out in point 2,
  - instruct the Presidency to prepare the budgetary documents to be sent to the
     European Parliament and to approve the draft letter in the Annex to that effect, and
  - have the Council Decision adopting the Council's position on draft amending budget
     No 3 of the European Union for the financial year 2021, as set out in document 9682/21,
     published in the Official Journal of the European Union.
