EXPLANATORY MEMORANDUM

1. CONTEXT OF THE DELEGATED ACT

The Hungarian language version of Delegated Regulation (EU) 2020/689 contains an error. In order to align that language version with the other language versions, a Delegated Regulation correcting Delegated Regulation (EU) 2020/689 needs to be adopted.

2. LEGAL ELEMENTS OF THE DELEGATED ACT

This Delegated Regulation corrects a translation error in the Hungarian language version of the text.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law')¹, and in particular Article 42(6) thereof,

Whereas:

- The Hungarian language version of Commission Delegated Regulation (EU) (1) 2020/689² contains an error in Part I, Chapter 1, Section 3, point 1, intorductory phrase, of Annex IV that alters the meaning of the provision.
- The Hungarian language version of Delegated Regulation (EU) 2020/689 should (2) therefore be corrected accordingly. The other language versions are not affected.

HAS ADOPTED THIS REGULATION:

Article 1

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.
