Subject:	Transfer of appropriations No DEC 13/2022 within Section III – Commission – of the general budget for 2022

1. On 30 May 2022, the Commission submitted to the Council proposal for transfer of appropriations No DEC 13/2022 related to the mobilisation of the European Globalisation Adjustment Fund (EGF/2021/008 EL/Attica electrical equipment manufacturing)¹, in accordance with Article 31(1) of the Financial Regulation².

The purpose of this transfer is to move an amount of EUR 1.5 million in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*), as recorded in 9583/22.
 3. The Budget Committee examined the proposal for a transfer at its meeting on 3 June 2022.
 4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in 9583/22; and
 - the draft letter in the ANNEX to that effect.
