On October 19th 2021, the “Israeli Minister of Defense”, Gantz, designated six leading Palestinian NGOs as terrorist organizations; apart from UAWC, these organizations are: Addameer, Al-Haq, Bisan Center, DCI-Palestine and UPWC.

UAWC supports thousands of Palestinian farmers and their families, mainly in “Area C” of the Occupied West Bank, where Israel’s illegal settlements are located. Our vital work to consolidate the Palestinian presence in “Area C” is the reason why we have been attacked for many years. Israel’s recent designation is the culmination of these attacks.



# Israeli Designation

Since the designations were announced, we have received countless messages of support. We are most grateful for these expressions of solidarity with UAWC and look forward to continuing the relationships with our governmental and civil society partners in Palestine and abroad.

We call on the international community, on Europe, to reject all designations and to mobilize effective pressure on Israel to revoke them. Apart from moral considerations, such pressure serves the interests of anyone committed to human rights and to a sustainable solution of the Israeli-Palestinian conflict based on two states.

## Challenges facing UAWC after the designation:



- 01** Dealing with the significant decline in funding, which impeded the provision of services to farmers.
- 02** Loss of a large number of key expert staff.
- 03** Fear of Israeli persecution, especially by local and foreign employees, farmers, and volunteers, as well as by donors.

## What did UAWC do to deal with this aggression?



- 01** Run, in partnership with many organizations, an international advocacy campaign to pressure Israel to reconsider its decision.
- 02** A communication and discussion campaign with many donors, including government donors, to continue funding and supporting UAWC and the rest of the organizations.
- 03** UAWC's submitted an appeal to the Israeli court against the decision, and we are now in the process of filing a lawsuit.
- 04** Registering a new organization to work temporarily as an alternative to the union in implementing projects and directly supporting farmers.

## What is required from the international community?



- 01** Quick and clear action to protect human rights defenders and workers in these organizations from the threat of Israeli targeting.
- 02** A clear and strong declaration of rejection to the Israeli decisions due to the lack of evidence /proofs to confirm their allegations.
- 03** Maintaining funding for the designated organizations and not allowing their work to be undermined.
- 04** Holding Israel accountable for its crimes against, its occupation and killing of thousands of Palestinians.

The Israeli occupation almost completely prevents the Palestinians from accessing their natural resources in “Area C”, which according to the World Bank and many other studies, would add about \$4 billion to the Palestinian national income

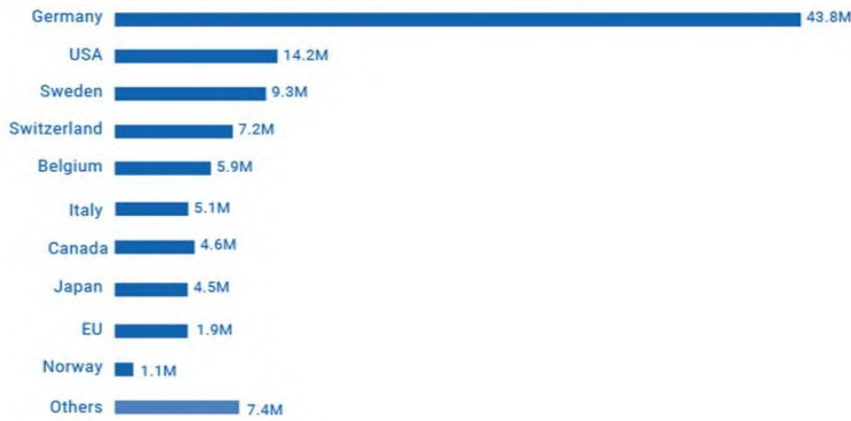

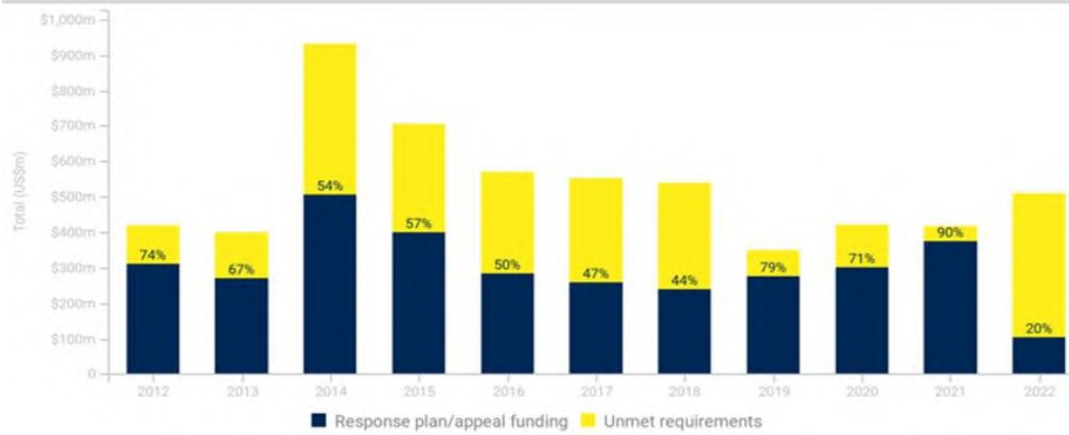
### HRP FUNDING BY DONOR | 16 MAY 2022

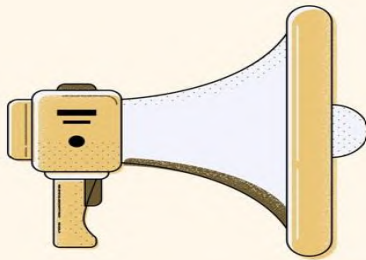

# Recommendations

Resume funding quickly to prevent further deterioration of the Palestinian humanitarian situation

Rejection of the Israeli designation decision and any targeting of Palestinian civil society organizations

Increasing pressure on European governments to prevent Israel from continuing its aggression against Palestinian human rights defenders
