RELEX.1 LIMITE EN

Whereas:

- (1) On 28 September 2017, the Council adopted Decision (CFSP) 2017/1775¹.
- On 13 December 2021, the Council adopted Decision (CFSP) 2021/2208², which established a new framework that provides for the imposition of additional restrictive measures against individuals and entities that are responsible for or complicit in, or having engaged, directly or indirectly, in actions or policies that threaten the peace, security or stability of Mali, or that obstruct or undermine the successful completion of Mali's political transition.
- On the basis of a review of the restrictive measures, as provided for in Article 8(1) of Decision (CFSP) 2017/1775, the entry for one person included in the lists of natural or legal persons, entities or bodies in sections A and B of the Annex to Decision (CFSP) 2017/1775 should be deleted.
- (4) Decision (CFSP) 2017/1775 should therefore be amended accordingly,
