Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union², and in particular Articles 23 and 24 thereof.

Whereas:

- (1) By its Decisions of 20 September 2022³, 25 October 2022⁴, 14 February 2023⁵ and 21 March 2023⁶, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2024.
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Nicolas KELLER.
- (3) The Government of Germany has submitted a nomination for the vacant seat,
