The SCA will prepare the ministerial debate at the September "Agriculture and Fisheries" Council. The Commission will provide information on the latest developments concerning trade in agri-food products. Delegations will have the opportunity to ask questions. However, due to timing constraints, the Presidency would encourage them to keep their interventions short.
