19/20 September 2018

Working Party on Horizontal Agricultural Questions – CAP Reform

After the first round of examination of the CAP Strategic Plan Regulation the Presidency would like the Working Party on Horizontal Agricultural Questions to examine certain provisions of the proposal for a Regulation of the European Parliament and the Council on the financing, management and monitoring of the common agricultural policy and repealing Regulation (EU) No 1306/2013 (hereinafter "Horizontal Regulation") that are linked to the CAP Strategic Plan Regulation. The Presidency also invites the Commission to provide further clarifications on specific aspects of the CAP Strategic Plan Regulation and its interlinkages with the Proposal for Common Provisions Regulation.

The meeting on 19/20 September is scheduled to take place in room 35.4 of the Justus Lipsius building. The meeting will start on 19 September at 10.00 and continue on 20 September at 9.30.

On 19 September, we propose to examine Title IV, Chapters II (Integrated administration and control system) and IV (Control system and penalties in relation to conditionality) of the Horizontal Regulation. We expect to cover:

- Chapter II (Art. 63 to 73) in the morning;
- Chapter IV (Art. 84 to 87) in the afternoon.

On each block of Articles, the Commission will first give a presentation and delegations will then have the opportunity to express their views and ask questions, followed by replies from the Commission.

On 20 September, the Commission will provide additional clarifications on the following items of the CAP Strategic Plan Regulation on the basis of the written contributions received from delegations:

- definitions (Art. 3 and 4);
- conditionality (Art. 11 and 12), including Annex III;
- financial provisions (Art. 79 to 90), with a focus on unit amounts (Art. 88-89);
- types of interventions for rural development (Art. 64-78).

The Commission will also inform delegations on the interlinkages between the proposed provisions of the CAP Strategic Plan Regulation on rural development and the proposal for a Common Provision Regulation.

Delegations will then have the opportunity to ask further questions.

We would like to inform delegations that they will be requested to submit their written comments on the articles covered during the meeting by 24 September by using a table which will be provided in due time.
