### **WORKING PARTY ON HORIZONTAL AGRICULTURAL QUESTIONS - CAP REFORM**

The Presidency would like to pursue the technical examination of the proposal for a Regulation of the European Parliament and of the Council establishing rules on support for strategic plans to be drawn up by Member States under the Common agricultural policy (CAP Strategic Plans) and financed by the European Agricultural Guarantee Fund (EAGF) and by the European Agricultural Fund for Rural Development (EAFRD) and repealing Regulation (EU) No 1305/2013 of the European Parliament and of the Council and Regulation (EU) No 1307/2013 of the European Parliament and of the Council (hereinafter "CAP Strategic Plans Regulation").

The meeting will take place on 9-10 October in room LEX 1 of the LEX building. The meeting will start on 9 October at 10.00 and continue on 10 October at 9.30.

We would propose to structure the meeting as follows:

#### Wednesday 9 October:

Based on Member States' written comments, the Presidency will present **new drafting suggestions** on articles not addressed in previous meetings (WK 10735/2019). We would propose to examine those drafting suggestions as follows:

- Part 1 (morning): direct payments (Articles 15a-33, except Article 28);
- Part 2 (afternoon): financial provisions (with regard to issues not linked to the horizontal MFF negotiations), CAP Strategic Plan and administrative issues (Articles 79-142).

In <u>each part</u>, the Commission will reply to relevant questions from Member States, and delegations will be invited to express their views on the following questions:

- Would you consider the new drafting suggestions acceptable?
- Are there any other issues on which you would need additional explanations?

The Presidency intends to organise a table round for each part.

# Thursday 10 October:

Following the exchange of views held on 13 September, the Presidency intends to continue the discussion on the **new delivery model** (NDM). To this end:

- The Commission will be invited to make a presentation on relevant aspects on NDM;
- Delegations will be invited to provide their own examples on the implementation of the NDM if they wish.

The Presidency will give the floor to delegations, and the Commission will reply to relevant questions raised by Member States.
