Exchange of views

Preparation of the Council debate

The SCA will prepare the ministerial debate at the September AGRIFISH Council. The Presidency has invited the Commission to present the connections, synergies and funding opportunities between the agricultural aspects of the CAP proposals, the NRP proposal ("the Fund"), the Performance Regulation proposal and the proposal on the European Competitiveness Fund, including which instruments and funding streams are available for agriculture across the different regulations, and what funding is relevant for agriculture. Delegations will have the opportunity to ask questions.

Delegated acts planned for the second half of 2025

Information from the Commission

The Commission will be invited to indicate the Delegated Acts it expects to adopt during the second semester. No discussion on substance is foreseen but delegations will have the possibility to flag delegated acts they consider to be of particular importance and ask questions for clarification.

Trade-related agricultural issues

Preparation of the Council debate

To prepare the debate at the September Council meeting, the Commission will update the committee on the latest developments, particularly its proposals for approval of the Mercosur and Mexico agreements and regarding trade relations with China and the USA. The Presidency will inform delegations about the organisation of the Council meeting.

Under this item, the Presidency will provide information on the “Agriculture and Fisheries” Council on 22-23 September 2025 and the next SCA meeting.
