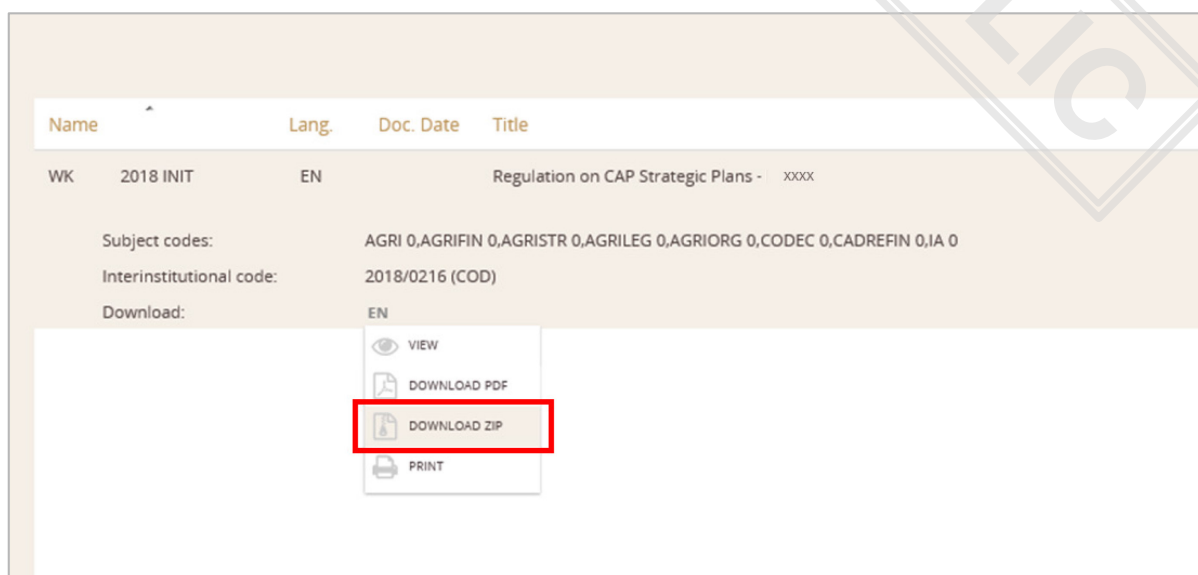

- **Add your drafting suggestions in column 3 ("Drafting suggestions")**. Please copy the Commission's proposed text and make the changes visible (in bold/strikethrough or other equivalent manner). **Do not use the "track changes"-option as such text severely complicates the further processing and readability of the document;**
- If the proposed changes concern only a specific part of an article/recital (e.g. an individual letter/indent), please **do not copy the full article but only the concerned part**;
- Add your comments related to the specific part of the text and/or your suggested changes in column 2 ("Comments"). Delegations should always provide justification for suggested changes to the Commission's proposal as this will allow the Presidency to efficiently and convincingly communicate the Council's position to the European Parliament.
