Subject: Vineyard areas in Member States

The table below compares the vineyard areas in the 13 Member States participating in the planting authorisations scheme with the “theoretical basis” of the area in 2014/2015 (used as reference in the first year of the application of the new system), plus the old planting rights convertible as from 2016.
