BUDGET HEADING 1. (Cross-) Regional workshops

1. Operational Activities

- Organisation and implementation of a Regional Workshop for the MENA Region, 27 29 August 2024, in Aqaba, Jordan.
- Organisation and implementation of a Cross-Regional Workshop for the Caucasus and Central Asia, 06 07 November 2024, in Ulaanbaatar, Mongolia.

2. Achievements

- On 27 29 August 2024, a Regional Workshop for the MENA Region was organized in Aqaba, Jordan. The two-and-a-half day event focused on the risk of diversion, i.e. EU Common Position criterion no.7, with presentations on end-user verification and controls, the role of customs in arms export control enforcement, and a field visit to Aqaba Airport. In the spirit of donor coordination, one representative from the EU League of Arab States Small Arms Project presented on the importance of stockpile management and marking and tracing to prevent diversion. 31 participants from the competent authorities from Algeria, Jordan, Morocco, Tunisia and Lebanon (online) attended the event. Two EU experts from Italy and Spain shared their expertise.
- On 6 7 November 2024, a Cross-Regional Workshop for Caucasus and Central Asia was organized in Ulaanbaatar, Mongolia. The two-day event focused on the latest developments and current debates on arms export controls in the EU, end-user verification and end-use documentation, post-shipment controls and interagency cooperation. It also offered a platform for the exchange of best practice experiences in the regions. 22 participants from the competent authorities from Armenia, Azerbaijan, Georgia, Kazakhstan, Kyrgyzstan and

Mongolia attended the event. Two experts from the Czech Republic and Bosnia and Herzegovina shared their expertise.

BUDGET HEADING 2. Multilateral Knowledge Exchange Activities

1. Operational Activities

- Planning and implementation of a study visit for Montenegro and Morocco to Estonia, held 26 27 September 2024 in Tallinn, Estonia.
- Planning and implementation of a binational workshop on transfer of technology for Kosovo* and North Macedonia (back-to-back with EU P2P 103 workshop), held on 11 – 12 November 2024 in Pristina, Kosovo*.

2. Achievements

- A study visit for Montenegro and Morocco was organised in Tallinn, Estonia. The event took place from 26 27 September 2024. The event addressed the topic of the control of transit and transhipment of arms and the importance of interagency cooperation, especially between the licensing authority and customs. The event also included an on-site visit to Muuga Port. Seven persons from relevant authorities in Montenegro and Morocco attended the event. Experts from Estonia provided expertise for this workshop.
- A binational workshop for North Macedonia and Kosovo* was organised in Pristina, Kosovo*. The event took place from 11 12 November 2024, back-to-back with an EU P2P P103 workshop, covering the same issues on the dual-use side. The event addressed the topic of transfer of technology; mainly the legal background of its control, the role of the private sector and outreach to industry. The event was attended by 20 persons from relevant authorities in North Macedonia and Kosovo*. This outreach activity was supported by four EU experts from Romania, Germany, Hungary, Slovenia and the Netherlands.

- Planning and preparation of an Individual Assistance Workshop for Ukraine, to be held in January 2025, online

2. Achievements

- An Online Individual Assistance Activity for Mongolia was organised online on 14 June 2024. The event
 was designed as a follow-up to the translation of the EU Common Military List (CML) into Mongolian in the
 framework of the Remote Assistance for Mongolia which was completed in May 2024. The event was attended
 by 18 representatives from Mongolia. One EU expert from Romania supported the workshop and introduced the
 participants to the structure and content of the EU CML.
- An Individual Assistance Workshop for Kyrgyzstan was organised in Issyk-Kul, Kyrgyzstan from 18 20
 June 2024. This activity took place in cooperation with the OSCE Programme Office in Bishkek (OSCE POiB)
 and the EU P2P P105 project. 21 Kyrgyz participants from different authorities attended the event. Two EU
 Experts from Germany and Romania supported the event. Discussions focused on the ATT, control lists and
 their associated technical assessments, the role of customs in inter-agency cooperation and in commodity
 identification.
- Online Individual Assistance Workshops for Ukraine were conducted on 07 July and 12 September to
 follow up on the remote assistance carried out in March and April of the same year and the in-person workshop
 in Warsaw in May, all of which contributed to the Review of the Draft Law on Strategic Trade Control organized
 in cooperation with the EU P2P Export Control Programme and the United States EXBS. Experts from Hungary
 and Germany supported the events.
- An Individual Assistance Workshop for Ukraine was organised in Warsaw, Poland, on 6 7 November. The
 event was designed as a follow-up to the remote legal analysis of the country's arms export control legislation
 and the following legal workshop in February 2024. The event was attended by eight representatives of relevant
 authorities from Ukraine. Three EU experts from Hungary, Romania and the Czech Republic supported the
 event, which addressed the issues spanning the entire licensing cycle: pre-licensing, licensing and postlicensing.
- An Individual Assistance Workshop for Kosovo* was organised in Pristina, Kosovo*, on 13 November. The
 event was designed as a follow-up to the remote legal analysis of the country's arms export control legislation
 and the following legal workshop in February 2024. The event was attended by six representatives of relevant
 authorities from Kosovo*, involved in the legal review process. One EU expert from Romania assisted in
 analysing the new draft legislation.

1. Operational Activities

- Organisation and implementation of an Institutional Capacity Building Activity for Serbia held on 11 September 2024 in Belgrade, Serbia.
- Organisation and implementation of an Advanced Capacity Building Peer-to-Peer Activity for Mongolia,
 Tajikistan and Turkmenistan, held on 24 26 September 2024 in Tirana, Albania.
- Organisation and implementation of an Advanced Capacity Building Peer-to-Peer Activity for Mongolia and Tajikistan, held on 4 – 5 December 2024 in Sarajevo, Bosnia and Herzegovina.

2. Achievements

- An Institutional Capacity Building Activity for Serbia was held on 11 September 2024 in Belgrade, Serbia, by supporting a self- organized outreach to industry event of Serbia. The outreach event for the Serbian industry for arms and military equipment was attended by around 130 participants and focused on the dissemination of information and best practices among the Serbian national industry. Besides the Serbian experts, the event was supported by one EU expert from Germany.
- An Advanced Capacity Building Peer-to-Peer Activity for Mongolia, Tajikistan and Turkmenistan was held on 24 26 September 2024 in Tirana, Albania. The event was attended by eight participants from Mongolia, Tajikistan and Turkmenistan. It was designed in the context of the train-the-trainer (TTT) program of BAFA in which Albania and Bosnia and Herzegovina previously participated. The event allowed the hosting country Albania to apply the lessons learned in the TTT context to design the substance of the event, in close cooperation with their "Peer" Country Bosnia and Herzegovina. The event focused on the basic components of an export control system, such as the legal basis and interagency cooperation and was designed to share such experiences and lessons with a core audience from Mongolia, Tajikistan and Turkmenistan.
- An Advanced Capacity Building Peer-to-Peer Activity for Mongolia and Tajikistan was held on 4 5 December 2024 in Sarajevo, Bosnia and Herzegovina. It, too, was designed in the context of the train-the-trainer (TTT) program of BAFA in which Bosnia and Herzegovina and Albania previously participated. The event allowed the hosting country Bosnia and Herzegovina to apply the lessons learned in the TTT context to design the substance of the event, in close cooperation with their "Peer" Country Albania. The event was attended by same four participants from Mongolia and Tajikistan (Turkmens could not participate) and build on the visit to Albania three months prior. The workshop in Sarajevo complemented the content of the activity in Albania by focusing on secondary legislation and how to design it, interagency cooperation between licensing and customs agencies, transit and transhipment controls, and the role of customs in arms export controls.
