Time permitting, RELEX will also revert to Art. 60, 61 and Annex IV, based on a revised proposal (to be circulated).

Way ahead: RELEX will discuss a text proposal for operations implementing assistance measures, following the RELEX informal of 17 November. RELEX will also discuss the recitals. It is the intention of Presidency to close the discussion of the EPF legal act in RELEX by the end of the week.
