14		(1) The European Chemicals Agency ('the Agency') was established by Article 75(1) of Regulation (EC) No 1907/2006 ¹ as the central entity to ensure the effective management of the technical, scientific and administrative aspects of that Regulation and their consistency at Union level, following the results of a feasibility study which concluded that an independent central entity offered a number of long-term advantages over other options. <u>1. The Agency has also played an important role in coordinating the communication around Regulation (EC) No 1907/2006 and has provided administrative support to the Commission, national competent authorities and duty holders.</p>

17	<p>(4) Since its establishment under Regulation (EC) No 1907/2006, additional tasks and responsibilities have been assigned to the Agency and its committees by other Union legislation in the fields of, for instance, chemicals, product safety and environmental policy. 




