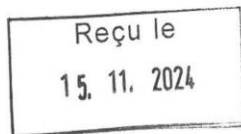

Subject: Selection procedure for the appointment of the European Data Protection Supervisor – Commission decision on the shortlist of candidates

Dear Secretaries-General,

According to Article 53 (1) of Regulation (EU) 2018/1725¹, the European Parliament and the Council appoint, by common accord, the European Data Protection Supervisor for a term of five years on the basis of a list drawn up by the Commission following a public call for candidates.

The Commission consulted your Institutions on the text of the vacancy notice and published it on 4 June 2024 under reference COM/2024/20107.

Following a selection process carried out in line with its internal procedures at Director-General level, the Commission decided on 13 November 2024 to adopt the following list of candidates, in alphabetical order, in view of the final decision to be taken by your Institutions:
