

LABEL FORMATTING IN CLP - FOR DISCUSSION IN ITM

The following table does not pre-empt the outcome of technical meetings and any outcome of the political trilogue(s). As for any other points, the Commission reserves its position until the finalisation of the interinstitutional negotiations.

In order to accommodate some concerns on the time needed to change from conventional to fold-out labels and, where necessary, to allow for the purchase of new equipment, using up existing label stocks, and potential needs to change the packaging design in extreme cases, we suggest the consideration of a longer transition period of 24 month after the entry into force for the provisions outlined in Annex I Section 1.2.1.4 and 1.2.1.5.

We are ready to prepare a legal drafting suggestion once a decision has been taken on all issues for which transition periods are still under discussion.
