## Presidency note to steer the discussion at WPTQ on the 6th of February 2023

At the Working Party, the Presidency will debrief from the technical meeting with the European Parliament to be held on the 3<sup>rd</sup> of February. MS will be invited to again express views as concerns the EP response to the Council's approach to the issues of Horizontal Provisions, Union Interest and Reparation of Injury, following the previous discussions in the Working Party. The next technical meeting with the EP is scheduled to hold on the 9<sup>th</sup> of February.

In order to focus the discussions at the level of the Working Party, the discussions are based on specific clusters, following the cluster terminology as agreed with the EP (WK 1065/2023 INIT).

For the Working Party on the 6<sup>th</sup> of February, the Presidency proposes to focus on the clusters listed in the table below. In the updated version of the 5-column document to be circulated, you will find the Presidency's proposed assessment of the Commission proposed compromise text of the 9<sup>th</sup> of January 2023.

- 2. Do you have specific drafting suggestions for the lines discussed?
