The Danish Presidency is pleased to invite delegates to the sixth and final meeting of this Working Party during its Presidency term.

The notice for the meeting and provisional agenda has been published in **CM 5043/25**.

Member States's attendance will be limited to 2+2.

1. Proposal for a REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the production and marketing of plant reproductive material in the Union, amending Regulations (EU) 2016/2031, 2017/625 and 2018/848 of the European Parliament and of the Council, and repealing Council Directives 66/401/EEC, 66/402/EEC, 68/193/EEC, 2002/53/EC, 2002/54/EC, 2002/55/EC, 2002/56/EC, 2002/57/EC, 2008/72/EC and 2008/90/EC (11502/23 + ADD 1)
– *Final examination of the compromise text*

The Working Party will have a last round of discussion on the compromise text.

Discussions will focus on the Presidency's revised text on the recitals, and on the final consolidated compromise text.

The Presidency has sent a revised version of the recitals for written consultation. Based on the comments received during the written consultation, the recitals will be further amended. This newly revised text will be published before the meeting and will be the basis of the discussion.

The Presidency has also published a consolidated version of the compromise text reflecting the changes in comparison to the Commission proposal. The consolidated compromise text can be found in document ST 15452/2025. This document will be further revised based on the outcome of the VTC on 21 November.

The purpose of the discussion on the final compromise text is to check the consistency and the overall understanding of the text with the concluded changes. For this reason, focus will be on editorial changes and correction of inconsistencies. No changes to the content or substance are foreseen at this point.

At this meeting, the Presidency intends to conclude the discussions on the compromise text in its entirety, in order to be able to obtain a mandate from the Permanent Representatives Committee to start the interinstitutional negotiations.
