## Council conclusions on the safety of LGBTIQ persons in the European Union

#### The Council of the European Union,

- a. Recalling Article 2 of the Treaty on European Union, whereby the Union is founded on the values of respect for human dignity, freedom, democracy, equality, the rule of law and respect for human rights, including the rights of persons belonging to minorities and emphasising that Article 21 of the Charter of Fundamental Rights of the European Union (hereinafter 'Charter') explicitly prohibits any discrimination based on sex and sexual orientation;
- b. Underlining that human rights are universal, indivisible, interdependent and interrelated and that Member States have undertaken to guarantee the rights and freedoms enshrined in the Charter and in the European Convention for the Protection of Human Rights and Fundamental Freedoms for all people within their jurisdiction;
- c. Recalling that Articles 8 and 10 of the Treaty on the Functioning of the European Union (TFEU) provide that the Union in all its activities shall aim to eliminate inequalities and combat discrimination, including on the grounds of sex and sexual orientation, in defining and implementing its policies and activities, and that Article 19 TFEU empowers the Council to take action to combat discrimination on those grounds;
- ca. Recognising that intersecting forms of discrimination, including where
  discrimination against LGBTIQ persons intersects with other grounds, can
  contribute to exacerbating vulnerable situations, whereby LGBTIQ persons may
  be at increased risk of experiencing hate crime or hate speech.
- **d. Reaffirming** the importance of Directive 2012/29/EU (hereinafter 'Victims' Rights Directive') establishing minimum standards on the rights, support and protection of victims of crime, as it ensures that all victims of crime are recognised and treated in a respectful, sensitive, tailored, professional and non-discriminatory manner and **underlining** that the "EU Strategy on victims' rights (2020-2025)" addresses all

- victims of crime, while paying attention to the specific needs of persons in the most vulnerable situations, such as victims of anti-LGBTIQ<sup>1</sup> hate crime;
- **e. Reiterating** the Council conclusions of 6 December 2013 on combating hate crime in the European Union, as they recognise the clear link between promoting equality and fighting discrimination on the one hand, and tackling hate crimes on the other;
- **f. Reiterating** the Council conclusions of 16 June 2016 on LGBTI equality, as they underline the importance of advancing equality and combating discrimination, for example by comparative data collection and cooperation between stakeholders;
- **g. Reiterating** the Council conclusions of 5 March 2021 on strengthening the application of the Charter of Fundamental Rights in the European Union, as they highlight the persistence of serious problems and obstacles to everyone's full enjoyment of fundamental rights, including for LGBTIQ persons;
- h. Recalling the Council conclusions of 10 March 2023 on the application of the EU Charter of Fundamental Rights and the role of the civic space in protecting and promoting fundamental rights in the EU, as civil society organisations and human rights defenders play an indispensable role in the protection of LGBTIQ persons from violence, harassment and discrimination;
- i. Underlining the shared responsibility between the European Parliament, the Council and the Commission together with the Member States, to protect and promote fundamental rights, including to ensure equal treatment and equality for all;
- **j. Recognising** the importance of joint efforts with international organisations, such as the Council of Europe, the Organization for Security and Co-operation in Europe and the United Nations, in protecting and promoting the full enjoyment of human rights for all, including for LGBTIQ persons;
- k. Condemning the Russian war of aggression against Ukraine and acknowledging with concern the increased risk for stigmatisation, violence, harassment and discrimination of LGBTIQ persons arising from the war, as well as the resulting increased levels of disinformation, that follow in its tracks.

The Council of the European Union **affirms** its commitment to eliminate inequalities and **approves** the following conclusions.

### The situation of LGBTIQ persons in the European Union

#### The Council of the European Union,

- 1. **Welcomes** that the European Union Agency for Fundamental Rights (hereinafter 'Fundamental Rights Agency') continually carries out comparative EU wide surveys of the situation of LGBTI<sup>2</sup> persons in the Union which serve to develop comparable data on the respect, protection and fulfilment of the fundamental rights of LGBTIQ persons, as such data are a crucial element in following the development over time and in supporting policy development;
- 2. Recognises the worrying fact that a comparison of the results of the 2012<sup>3</sup> and 2019<sup>4</sup> surveys shows show little <u>overall</u>, if any, progress <u>and</u>, in some respects, a <u>potentially deteriorating situation within the EU</u>, and stresses that the findings in the 2019 survey indicate recurring problems for LGBTI persons' enjoyment of their fundamental rights and highlight the need for a more effective application of the relevant EU acquis;
- 3. Condemns the persistence of violence, harassment and discrimination against LGBTIQ persons across the Union, highlighted by the fact that the 2019 survey shows that significant numbers of persons continue to experience such acts due to being LGBTI, and is alarmed by the low rate of reporting of such incidents to the police or any other competent body;
- 4. **Deplores** that over half of respondents **to those surveys** feel compelled to hide their sexual orientation or gender identity most of the time and particularly in public spaces, that around 40 % of those open about being LGBTI report experiences of harassment, and that physical or sexual attacks remain prevalent as **indicated by the fact that** one in ten respondents reports having been the target of such violence during the five-year period prior to the survey, with trans and intersex respondents showing

#### significantly higher exposure to violence;

5. **Calls on** the Fundamental Rights Agency to continue to carry out surveys on the situation of LGBTIQ persons **in all areas of life, both online and offline**, including by regularly compiling high-quality data based on the most reliable methods to allow for a comparison over time.

### Protecting LGBTIQ persons from violence, harassment and discrimination

### The Council of the European Union commits to:

- 6. Promote and support the fundamental right of all <u>persons within the EU citizens</u>, including LGBTIQ persons, to be safe from violence, harassment and discrimination: <u>continuously address violations of fundamental rights, including by responding to such violations against LGBTIQ persons</u> and to keep matters of LGBTIQ safety on the political agenda;
- 7. Regularly follow up on the state of play of LGBTIQ equality in general, and of the safety of LGBTIQ persons in particular, including by examining relevant reports and studies presented by the Commission, the Fundamental Rights Agency and other relevant bodies and institutions, thereby providing a forum to take stock of progress and exchange views.

# The Council of the European Union invites Member States, within their national competences, to:

- 8. **Prevent** all forms of violence, harassment and discrimination and ensure that national administrations, including law enforcement, judicial authorities and equality bodies, are specifically **and sufficiently** equipped to protect **and, where appropriate, promote** the fundamental rights of LGBTIQ persons;
- 9. Protect LGBTIQ persons from hate crimes, hate speech, acts of violence and harmful practices, both online and offline, for instance by developing methods to identify, record and investigate offences committed with an anti-LGBTIQ motivation <u>as well</u> as by encouraging the reporting of such offences by victims and witnesses or by providing training to law enforcement personnel, judicial authorities, agencies <u>or organisations</u> delivering victim support services and other relevant authorities;

- 10. Counteract the spread of conspiracy narratives and malign information influence relating to LGBTIQ persons, with due respect for the right to freedom of expression and information as well as the protection of and protect persons and communities affected by such phenomena, for instance by building capacity to identify, prevent and counter foreign interference, information manipulation, misinformation and disinformation, with due respect for fundamental rights, including the right to freedom of expression and information and other dissemination of misleading information;
- 11. **Ensure a robust structure** to gather information on the <del>current</del> <u>evolution of the</u> national situation on the safety of LGBTIQ persons in particular, and LGBTIQ equality in general, for example through the equality <u>bodies</u> body or another competent body;
- 12. **Take measures** to ensure that LGBTIQ persons and human rights defenders can **exercise their right to freedom of expression, freedom of peaceful assembly and freedom of association at all levels** express their views without fear of violence, harassment or other forms **any form** of **coercion** recrimination, including by ensuring the rights to freedom of peaceful assembly and to freedom of association at all levels;
- 13. **Take into account** the increased need to address the safety of LGBTIQ persons in times of crises; this need has been highlighted, for example, by reports indicating that the COVID-19 pandemic has led to increased levels of hatred, violence and discrimination against LGBTIQ persons<sup>5</sup>;
- 14. Safeguard the dignity, human rights and fundamental freedoms of <u>all</u> persons who have fled the Russian war of aggression against Ukraine, <u>and take into account the increased risk of vulnerability that all including those of LGBTIQ refugees and asylum seekers may be subject to persons who may be more vulnerable.</u>

The Council of the European Union welcomes:

15. Welcomes the continued commitment of the Commission to LGBTIQ equality as well as their work to that end, and appreciates the strategic guidance provided by

the Commission LGBTIQ Equality Strategy 2020-2025, <u>including</u> in particular the pillar on safety, as well as the continued commitment of the Commission to LGBTIQ equality;

16. <u>Stresses its support for</u> the intention of the Commission to ensure coherence between the Strategy and the Council Guidelines <u>of 24 June 2013</u> to promote and protect the enjoyment of all human rights by LGBTI persons in the context of the EU's external policy and <u>calls on</u> the High Representative and the Commission to integrate LGBTIQ equality, in particular matters of safety, <u>and the decriminalisation of consenting same-sex relations</u> into external action.

16a. Underscores the importance of ensuring that the safety and equal treatment of

LGBTIQ persons is addressed in the context of the accession negotiation process

of candidate countries and in the stabilisation and association process.

#### The Council of the European Union invites the Commission to:

- 17. **Uphold and step up efforts** to ensure the protection of LGBTIQ persons from violence, harassment and discrimination, including hate speech and hate crimes, as a priority of the Union; such efforts should support Member States to provide comprehensive protection against such incidents, for example through facilitating exchanges of best practices;
- 18. **Facilitate** the work of the Subgroup on Equality Data to establish a guidance note on the collection and use of data on LGBTIQ equality, which can be used in efforts to collect data regarding violence, harassment and discrimination;
- 19. **Continue and step up** its work to prevent and combat the spread of online hate speech and violent extremist content against LGBTIQ persons, for example through the Code of Conduct on countering hate speech online<sup>6</sup>, as well as through the work of the EU Internet Forum to prevent radicalisation and violent extremism;
- 20. **Provide** a mid-term review of the LGBTIQ Equality Strategy 2020-2025 by the end of 2023 and regularly thereafter **report** on the progress made, as well as **inform** Member States of any developments through the High-Level Group on Non-Discrimination,

Equality and Diversity and the LGBTIQ Equality Subgroup;

21. **Ensure** adequate funding for civil society organisations, human rights defenders and other relevant actors that counteract violence, harassment and discrimination of LGBTIQ persons, as well as **provide** support funding for organisations supporting victims, through relevant funding programmes, such as the Citizens, Equality, Rights and Values programme.

#### The Council of the European Union invites:

- 22. The European Union Agency for Law Enforcement Training (CEPOL) and the European Judicial Training Network (EJTN) to provide Member States with expertise and support to advance their efforts in hate crime training in order to ensure the safety of LGBTIQ persons;
- 23. The Fundamental Rights Agency to **continue to provide** Member States with expertise and support to improve data collection systems through improved reporting and recording of hate crimes;
- 24. The Fundamental Rights Agency and the European Institute for Gender Equality (EIGE), within their respective mandates, to continue to provide Member States with assistance and expertise on the design and implementation of the collection of data on the situation of LGBTIQ persons, thereby facilitating comparability over time;
- 25. The European Agency for Safety and Health at Work (EU-OSHA) to gather and disseminate knowledge and tools to improve the occupational safety and health of LGBTIQ persons, including to protect workers from violence, harassment and discrimination in the workplace.
