- x Visa-free regime for short stays
 - i Stay of up to 1 year
 - ii This country is part of a group which benefits from the Summer Season visa waiver for tourism reasons
 - iii Visa-free access for 30 days from date of entry (for a total stay of maximum 90 days in a year).
 - iv Stay of up to 30 days
 - v Stay of up to 45 days
 - vi Stay of up to 30 days within period of one year
 - vii Russia benefitted from a seasonal visa waiver for tourism between 1 May and 30 September 2022.
 - viii Will expire in March 2025.
 - ix From 3 February 2025
 - * Except citizens of Bangladesh, Afghanistan, Syria, Pakistan, Somalia and India.
