The Croatian Presidency will continue discussion on:

Definitive VAT regime

- Including key elements of the Proposal with the view not to prevent or slow down efforts to improve the current VAT system
- Accompanying measures using the advantages of modern technology in order to facilitate and simplify tax compliance and reduce tax fraud



Value Added Tax

VAT rates proposal

Financial Transaction Tax

The Croatian Presidency will:

- Facilitate strategic debate on the state of play primarily at HLWP meeting
- Organize and facilitate discussion in an inclusive manner when enhanced cooperation participating MS table the draft text of the proposal



Common Corporate Tax Base

The Croatian Presidency intends to continue:

- Discussion at technical level on the core elements of the common corporate tax base in order to allow further progress on this file
- Monitoring the developments at OECD/G20 level



FISCALIS programme 2021-2027

The Croatian Presidency will:

- Resume the work on the FISCALIS programme after the finalization of the MFF negotiations.



Code of Conduct Subgroups

Subgroup on external issues:

- Revision of the EU list of non-cooperative jurisdictions
- Extension of the geographical scope
- Resume discussions and look for an agreement on new criterion 1.4. Exchange of beneficial ownership information

Subgroup on internal issues:

- Standstill/rollback review process
- Monitoring of the implementation of the agreed guidance

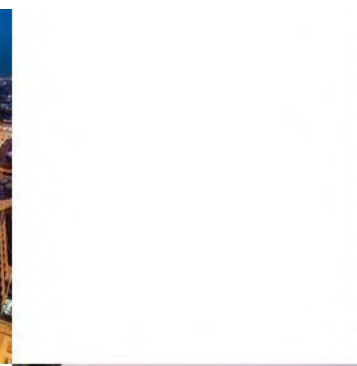
