## WP COMPCRO (Internal Market) – DSA

Dear Colleagues,

We are happy to invite you to our first Working Party on Competitiveness and Growth (Internal Market) on 1 July to discuss the Digital Services Act proposal.

We will continue the discussions on the first compromise proposal prepared by the Portuguese Presidency. During our meetings in July, we will focus on the Articles of the compromise that have not yet been discussed, so we will start with Articles 2-7.

Keeping in mind the call by our leaders and the commitment of the Slovenian Presidency to reach a General Approach in November Council meeting, we expect the delegations to clearly state their positions in our meetings. We need to move from the examination mode to the negotiating mode. The Presidency is counting on your support and engagement.

With this objective in mind, we will invite you to send your written comments on the articles discussed in the Working Party by the Friday of the following week after the meeting. The written comments on Articles 2-7 and their respective recitals, as well as on Articles 8, 9, 39(3), 40, 45, 46, 50-57 and their respective recitals should thus be sent by **Friday, 9 July** to the Council Secretariat ( [REDACTED] ) and to the Presidency ( [REDACTED] and [REDACTED] ). You are invited to send concrete drafting suggestions included as tracked changes in the first compromise text (document ST 9288/1/21 REV 1).
