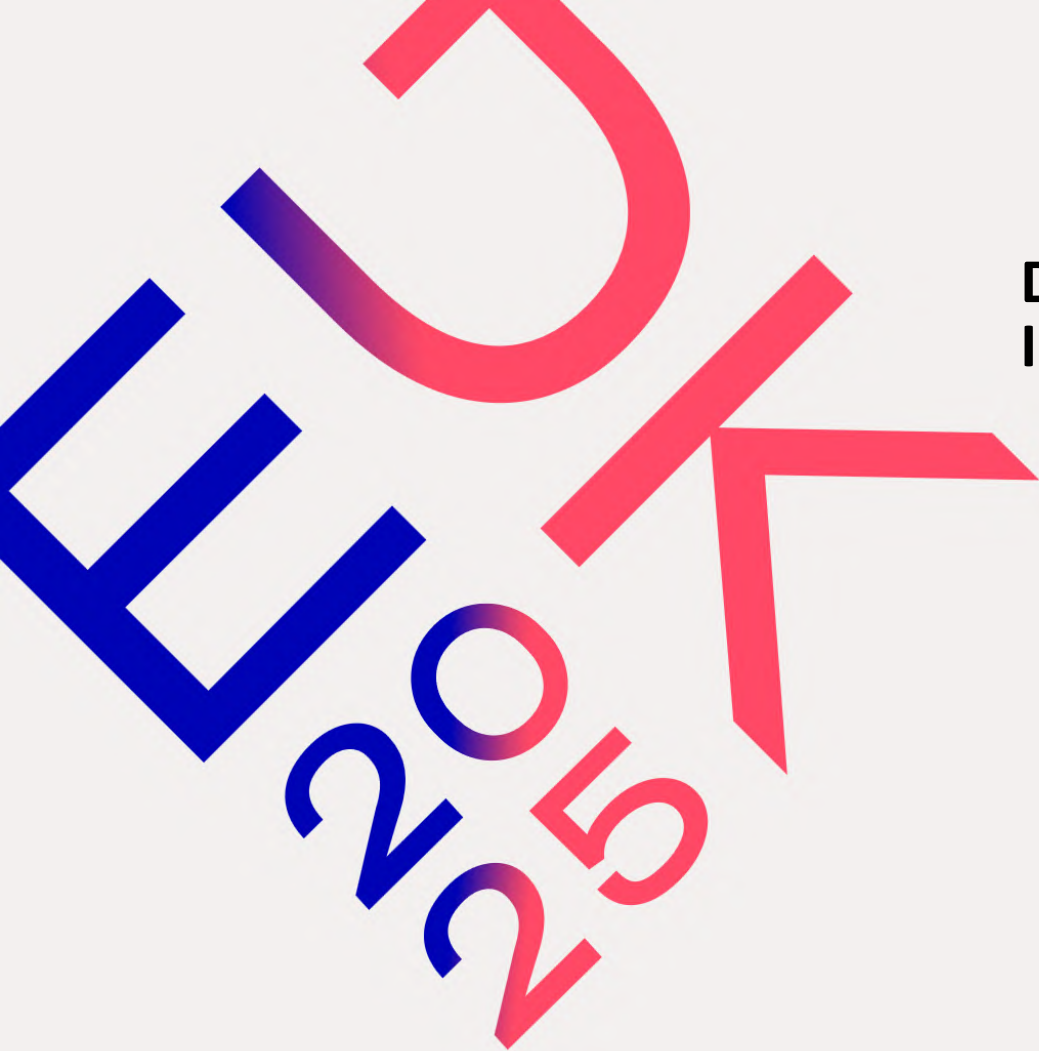

## DENMARK'S PRIORITIES UNDER THE MINISTER OF IMMIGRATION AND INTEGRATION

- Further strengthening the EU's external borders
- Effective returns of third country nationals staying illegally in the Union
- Implementation of the Pact on Migration and Asylum
- New solutions as a supplement to the Pact



## VWP: KEY PRIORITIES

Strategic use of the EU visa policy:

- Visa restrictions as a policy tool – including possible use of the revised Visa Suspension Mechanism
- Prevention of Visa Shopping
- Discussions on the Commission's EU Visa Strategy

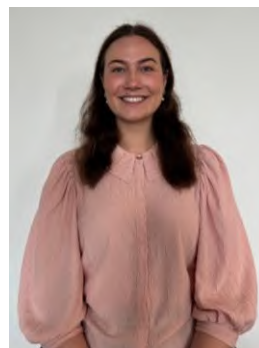
