Goals & Scenarios

Main goal: General approach (GA)

- GA in October 2023 & begin trilogues
- BE finishes trilogues.
- This implies a compromise text by the end of September 2023.



Working methodology

- Identification of MS' red lines.
- **Efficiency** of meetings:
 - Comments in **written form**, using **common format** for text proposals.
 - Cleaning of non-substantial elements.
 - Avoid long technical interventions and circular discussions.
 - Avoid "nice to have".

We will continue working with the Swedish presidency compromise text, document number ST 8171 2023 REV1 (herein after "compromise text").

Working methodology

involve all MS identify red lines reach agreements

Before WP meeting:

informal contacts documents in advance

During WP meeting:

efficient meetings focused interventions

written comments on specific issues cleaning of non-substantial elements
